Core Cyber

Carrier: Berkley Assurance Company

Program Limits:

- Aggregate: Up to \$12M
- Single Event: \$5M Occurrence / \$10M Aggregate

Member Limits:

- \$4M per Occurrence/Aggregate

Sublimits:

- \$2M per Occurrence/Aggregate
 - Ransomware/Extortion, Contingent Business Interruption, Reputation Risk
- \$500K per Occurrence/Aggregate
 - Social Engineering, Cyber Crime
- \$250K per Occurrence/Aggregate
 - Invoice Fraud, Cryptojacking, Telecommunication Fraud, Data Protection Regulation

Deductibles:

- K-12 <9K ADA: \$25K (from \$35K)
- K-12 >9K ADA: \$35K (from \$50K)
- CCDs: \$100K (from \$125K)

Optional Excess Cyber

Carrier: AIG Specialty Insurance Co.

Program Limits:

- Aggregate: Up to \$840M
- Single Event: \$25M Occurrence/\$50M Aggregate

Member Limits:

- \$2M per Occurrence/Aggregate
 - \$2M dedicated to each purchasing member

Sublimits:

- \$1M per Occurrence/Aggregate
 - Ransomware/Extortion, Contingent Business Interruption, Reputation Risk
- \$250K per Occurrence/Aggregate
 - Social Engineering, Cyber Crime
- \$125K per Occurrence/Aggregate
 - Invoice Fraud, Cryptojacking, Telecommunication Fraud, Data Protection Regulation
