Terminology	Description
SAFER Cyber Risk Assessment	Personalized report summarizing external findings, compliance gaps, benchmark comparisons, and prioritized remediation guidance.

Incident Response Plan (IRP)	Incident Response template detailing roles, responsibilities, and step-by-step actions for responding to security incidents.

Large Vendor Risk Assessments	Information security review of major third-party vendors to uncover potential supply-chain risk before contract award or renewal.
vCISO Coaching Sessions	One-on-one or small-group mentoring to guide strategy, policy, and program maturity efforts.
Incident Readiness Reviews	Review and provide guidance around an organization's existing or draft Incident Response Plan.
Ransomware Risk Assessments	Targeted assessments that measure ransomware exposure, control gaps, and recovery readiness.

Large RFP Reviews	Review large Request For Proposals (RFPs) for security inclusivity and concerns as well as strategies for vendor negotiation and budget maximization.
External Attack Surface Assessment (EASA)	Analysis of publicly facing IPs, domains, and services to identify potential exposures an adversary could exploit.
Web Application Scans (WAS)	Security scanning of web applications for potential vulnerabilities and misconfigurations.
Dark Web Exposure Analysis (DWEA)	Review exposure of stolen credentials or data tied to an organization's domain.
Cyber Resilience Training	Role-based training track for finance, HR, cabinet, and other high-impact positions on sophisticated phishing, AI deepfakes, and policy controls. Delivered live in small-group setting or video on demand.
Personal Cyber Risk Profiles (Pilot)	Pilot program delivering individualized risk reports that blend external scanning with self-reported data for up to 100 members.
Ask the Expert	On-demand support channel for follow-up questions and deeper guidance on cybersecurity topics.
Cybersecurity Roundtables	Small-group roundtables designed for members that may lack accessible IT resources to ask questions and learn about information security.
